How to Qualify for the Multi-Family Bin Bundling Program

Multi-Family complexes can choose a reduced rate 2-material bin bundle that best fits their needs. If you are currently taking advantage of the Multi-Family Bin Bundling Program please note that all accounts are being audited; there may be adjustments to billing and services.

MULTI-FAMILY BIN BUNDLING PROGRAM:

1. Pick your first container.

- Containers must be between 1-3 cubic yards (cy) in size. Containers over 3 cy will not qualify for bundling.

2. Pick a second container.

- Second container must match the first container type (bin or cart), quantity and frequency.
- If the second container size exceeds the size of the first container, a per cubic yard or per gallon (bin or cart) supplemental fee for the additional capacity will apply.
- If the second container requires additional collection (higher frequency) than the first container, the additional frequencies will be charged at an A LA CARTE rate.

3. Need a third material?

- Collection for unbundled materials (any container, size or frequency) can be added. An A LA CARTE rate applies.

*PLEASE NOTE: Bins and carts cannot be combined in a single bundle. A customer can have multiple separate bundles (bin bundles and cart bundles) on one account.



For multi-family bin bundling rates to apply, these items must be the same for both containers in the bundle:

- MATCHING* containers. Bins with bins and carts with carts
- NUMBER of containers.
- **FREQUENCY** of service.

BIN SECOND CONTAINER - 1 - 3 CUBIC YARDS, ANY MATERIAL OTHER THAN FIRST

ADDITIONAL FREQUENCIES OF SERVICE WILL BE CHARGED AT THE A LA CARTE RATE.
