

**Proper Set Out**

- Be sure your carts are at the curb by 6:00 am on your collection day. Log into your account or contact us to find out when we service your area.
- Leave the carts at the curb until we've emptied them. ***Our trucks can arrive at different times each week.***
- Place your carts facing the street with wheels against the curb (if possible).



- Leave 3 feet between each cart.
- Do not place carts close to parked cars, fire hydrants, low-hanging branches, parking meters, utility poles and other obstacles.
- Do not overload your carts. ***The lids should close completely.***
- Set overflow recycling in paper grocery bags next to the blue cart. Overflow garbage will not be collected unless you have affixed pre-paid tags to your trash bag. Call ACI to purchase tags or to arrange for additional service.
- Do not wedge or compact materials into your carts. Doing so will prevent your cart from being fully emptied when serviced.
- Materials from a construction, demolition or landscaping project do not belong in your carts. Call ACI to order a temporary debris box for these items.

**On-Call Clean Up Program**

San Leandro residents of single-family homes and multi-family complexes, with eight units or less, may schedule a cleanup once per 12-month period at no charge. Contact ACI to determine eligibility and to schedule your cleanup.



**PUT HAZARDOUS WASTE IN THE RIGHT PLACE.**

Hazardous items like pesticides, fertilizers, pool & photo chemicals, paint/varnish, toxic cleaning products, smoke detectors, mercury-containing items (thermometers, CFLs/fluorescent lights, etc.), unwanted medications, and sharps (needles, lancets, etc.) need to be taken to a hazardous waste collection facility. **Batteries & Latex Paint**

Residents may drop off household batteries (A, AA, AAA, C, D and 9-volt), at the ACI office. No car batteries allowed. Latex paint is accepted through ACI's on-call clean up program.

# What Belongs in the Recyclables?

## Paper Products

Any recyclable paper that tears, including:

- magazines, newspapers, and junk mail.
- aseptic boxes and dairy cartons.
- corrugated cardboard - Flatten boxes, fold/cut to pieces 2' x 2' or smaller, fit pieces loosely to assure the cart will empty properly during service.
- shredded paper - contained in a paper bag or box.

## Glass Bottles & Jars

- please remove lids & recycle

## Aluminum & Metal

Including:

- scrap pieces, up to 30 lbs. per item.

## Plastic Containers Labeled with ♻️

### Please Remember:

- No Plastic Bags
- No Film Plastic
- No Styrofoam®
- No Pressurized Tanks

Put household batteries in a zipper-lock style bag and place on top of your recyclables cart for collection. Put used motor oil in a sealed 1-gallon, screw-top container, and used oil filters in a sealed zipper-lock style bag. Place them next to (not inside) your Recyclables cart. Free oil jugs and oil filter bags may be requested from ACI. No other automotive liquids accepted.

# What Belongs in the Organics?

## Food Scraps

All fresh, frozen, cooked and moldy food scraps, including:

- bread, rice, pasta, cereals, & grains
- coffee grounds & tea leaves
- dairy products
- egg shells
- fruits & vegetables
- meat & bones
- nuts & shells
- pits, peels, skins, & rinds

## Food-Soiled Paper

Including:

- bags and newspaper used to contain food scraps or line your kitchen pail and cart.
- waxed paper and wax-coated boxes.

## Yard Trimmings

Including:

- branches less than 6" in diameter.

### Please Remember:

- No Glass, Metal, Styrofoam or Plastic
- No Aseptic Boxes
- No Liquid Fat, Oil or Grease
- No Pet Litter or Feces
- No Palm Fronds
- No Dirt, Rock, Concrete, Brick or Treated Wood

For your convenience, a handy kitchen pail for the collection of food scraps and food-soiled paper is available from ACI. Simply empty the contents of the pail into your green Organics cart.



# What Belongs in the Garbage?

## Non-Recyclable Glass

Including:

- dishware/ceramics.
- window glass/mirror.
- incandescent lightbulbs (no fluorescent, CFL, or LED bulbs).

## Non-Recyclable Paper

Including:

- laminated items
- metallic/embellished wrapping paper
- paper used for cleaning (not food-soiled)
- photographs.
- non-recyclable packaging.

## Non-Recyclable Plastics NOT marked with ♻️

Including:

- plastic film, wrap, & bags
- plastic straws & stir sticks
- Styrofoam® cups, plates, packaging peanuts, & blocks

## Other

- diapers, wipes, and personal hygiene items
- pet feces (please bag)
- shoes, clothing, textiles, and toys (that cannot be donated)
- treated wood

### Please Remember:

- No Organic or Recyclable Materials
- No Dirt, Rock, Concrete, or Brick
- No Paint, Batteries, Fluorescent Bulbs, Poison, or other Household Hazardous Waste (HHW)
