

n early May, CVSan's Collection System Maintenance Department team members participated in a parade with other essential agencies to support our local healthcare workers at Eden Medical Center. The CVSan Vac-Con truck and a support vehicle drove with firefighters, law enforcement officers,

Preparing for SB 1383

► VSan is preparing for Senate Bill (SB) 1383: Short-Lived Climate Pollutant Reduction Strategy, a landmark bill designed to reduce methane emissions by changing how organic waste is processed and recycled in California. The regulations will go into effect in 2022. The bill's goal is to reduce statewide landfilled organic waste by 75 percent by 2025 from the 2014 baseline.

Highlights of SB 1383 include requirements

- Provide organics collection services to all residents and businesses.
- Establish an edible food recovery program.
- Conduct education and outreach in the community.
- Monitor compliance and conduct enforcement.



Flush Only the 3Ps!

VSan's Collection System Maintenance Department staff continually inspect and clean public sewer mains. Consistent maintenance keeps the sewer system functioning properly. Please do your part to help prevent blockages and overflows

by keeping inappropriate materials out of public sewer mains. Remember, only toilet tissue and human waste should be flushed down the toilet. Nothing else is safe to flush, even products marketed as flushable, such as "flushable wipes." Only flush the 3 Ps: Pee, Poop, and Toilet Paper!

Pump Station Improvement Project

his summer, CVSan began work on the Aerial Pipeline and Pump Station Rehabilitation Project, which includes all eight of CVSan's pump stations. Where gravity flow is not possible, pump stations help to convey wastewater from a lower elevation to a higher elevation. The project includes adding necessary safety improvements, such as fall protection and sewer bypass connections, as well as mechanical and structural improvements, such as vault hatch repairs and pipe valve replacements.

Many public sewer lines are located in easements, so if you own property with an easement, we may ask for your cooperation as this project progresses. Replacing CVSan's aging infrastructure is a critical component of providing efficient service, maintaining our excellent customer service, and preventing sanitary

Sewer TV Inspection and Analysis

➤ VSan's Collection ✓ System Maintenance Department conducts sewer inspections using Closed-Circuit Television (CCTV) cameras. The information gathered from the CCTV inspections is crucial for CVSan's success. The Wastewater Department uses

CCTV data to check the condition of public sewer mains. The Engineering Department uses the data to help decide which pipes need repair and rehabilitation. Finally, the Collection System Maintenance Department uses the data to schedule preventative maintenance.
