

Custodians Care for Schools





Inflow and Infiltration (I&I) Reduction

nflow and infiltration is when unwanted water, such as rain water, enters the wastewater collection system. Too much I&I can overload the system and cause sanitary sewer overflows. In the two years since CVSan implemented the Private Sewer Lateral (PSL) Program, approximately eight miles of defective, leaky private sewer lateral (lateral) pipe have been replaced.

While that is less than one percent of the estimated miles of private sewer lateral pipeline that exist within CVSan's wastewater collection system, it does bring CVSan closer to its goal of reducing and eliminating I&I. As we continue to work towards I&I elimination over the coming years, we will reduce the stress on our wastewater collection system and reduce the wet weather capacity needed at the Castro Valley/Oro Loma Wastewater Treatment Plant.

Summer Recycles Day

CVSan's Recycles Day event will be held on Saturday, July 24, 2021, at Canyon Middle School from 8:00 a.m. to 2:00 p.m. Due to COVID-19, appointments will be required to participate and walk-ups will not be allowed access to the event.

Alameda County residents can drop off Household Hazardous Waste such as e-waste, paint, pharmaceuticals, household cleaners, and more. Castro Valley residents can also drop off textiles and pick up three bags of compost!


New Multi-Family Community Recognition Program
