Lateral Replacement Grant Program (LRGP)



VSan is pleased to announce that this year's Lateral Replacement ✓ Grant Program (LRGP) is scheduled to start at 7:30 a.m. on Monday, August 14, 2023. The LRGP is designed to help defray a portion of the costs when a property owner or their agent is required to replace the private sewer lateral, including the connection to the public sewer main. We are offering financial assistance to qualified applicants to replace defective private sewer laterals at 50% of the approved costs, up to a maximum reimbursement of \$2,000 per private sewer lateral. All work for the LRGP must be performed by a CVSan qualified contractor. A total of \$75,000 has been allocated to the program. For program information, please email **LRGP@cvsan.org**.

## **New Flusher Truck**



VSan recently welcomed a new vehicle to its maintenance fleet! The Vac-Con Hot Shot Jetter is equipped with powerful tools to increase productivity and efficient pipeline maintenance, and maintain regulatory compliance. This highpressure flusher can clear stones, flushed trash, accumulated Fats, Oils, and Grease (FOG), and other accumulated debris from the public sewer mains.

The new vehicle is also fitted with Chemical Root Treatment (CRT) equipment. CRT is the most effective way to kill roots to maintain free-flowing public sewer mains at a fraction of the cost of manually cutting roots. This CRT equipment will enable the Collection System Maintenance (CSM) Department to perform CRT maintenance work in-house rather than contracting it out.

#### **STEAM Project**

Science, Technology, Engineering, Art, and Math (STEAM) Kits were provided to 15 classrooms in Castro Valley. Over 400 students worked with STEAM prompts and supplies that would have been landfilled, and selected projects were displayed at the Castro Valley Library for two months.

#### **Reduce Wasted Food**

Over 660 silicone food huggers were given to 330 participants who learned food storage tips to reduce wasted food during events in front of the Dollar Tree.

CVSan spread awareness about bulk refill and container reuse at the Castro Valley Natural Grocery (CVNG). Over \$150.00 in discounts towards CVNG's liquid soap were given out.

# Your Rates

D id you know that CVSan has one of the lowest sewer service charges in Alameda County? CVSan uses a third party to review wastewater service rates every two years and notifies the public of any rate changes with a Proposition 218 notification.

On May 15, 2023 CVSan's Board of Directors

batteries are best suited for specific scenarios?

Alkaline batteries are best for lowdrain products that use occasional or very low power over extended periods. For example, smoke detectors, remote controls, emergency supplies, and wall clocks are best suited for disposable alkaline batteries.

**Rechargeable batteries** work best in highdrain devices that quickly drain energy. Examples of applications are children's toys or wireless computer mice.

Whichever battery type you choose, it is illegal to put batteries in your curbside containers. You may recycle batteries by placing them in a clear plastic bag on top of your blue recycling cart. Do you have clothes, linens, or towels at home that you no longer use? Between October 2<sup>nd</sup> - 6<sup>th</sup>, place bagged textiles on the curb. Please ensure bags are set out by 6:00 a.m. and visible to the Alameda County Industries (ACI) driver. Do not place bags behind or on top of carts.

Single-family residents: Set out textiles on your regular collection day.

Multi-family residents: Check with your property manager for your textile collection day. For full details and a complete list of acceptable items, please visit **cvsan.org/Textiles**. unanimously adopted Ordinance No. 195 to increase the sewer service charge by 7%. These changes are effective July 1, 2023. The approved charge includes the cost of customary goods and services used by CVSan, which have increased an average of 6% and are consistent with the Bay Area's cost of living adjustments.

In addition, CVSan has budgeted approximately \$27 million in funds during the next two-year budget cycle for major wastewater Capital Improvement Projects planned for operations, the treatment plant, underground pipelines, pump stations, and discharge facilities, with 80%, or \$22 million, of the Capital Improvement Project costs funding the new Operations and Engineering Building Project.
