Private Sewer Lateral (PSL) Program

re you planning to sell your home in spring or summer? Have you checked the condition of your private sewer lateral? When a property is sold, the private sewer lateral is required to meet compliance with CVSan's standards. A closed-circuit television (CCTV) permit must be obtained from CVSan, and the private sewer lateral inspection that a sewer contractor performs must be witnessed by a CVSan inspector. By meeting compliance, CVSan and the new property owner can be assured that the private sewer lateral is free of any cracks, roots, and other defects. ingle-use wipes, such as baby wipes, cleaning wipes, makeup wipes, and medicated wipes, have recently gained in popularity and are often mislabeled with the claim that they are flushable. However, many of these wipes are made from nonbiodegradable materials and do not actually break down after being flushed, causing them to linger in the wastewater collection system and contribute to clogs and blockages. Wipes of any kind should never be flushed down the toilet. They belong in the garbage. We can all take simple actions to ensure that Castro Valley's wastewater collection system stays functional. Please say No to Wipes!

Bag Batteries

ousehold batteries can be recycled curbside. Residents with blue recycling cart service can place used batteries in a clear zip-top bag on top of the recycling cart on collection day. Acceptable batteries are AAA, AA, B, C, D, 9V, and small "button" batteries. Please tape terminals on 9-volt batteries. Automotive, lithium-ion, or liquid batteries are not accepted. Do not place batteries directly inside the recycling cart – this could lead to potential fires.



GSAMP Update Completed

VSan recently completed an update to its Gravity Sewer Asset Management Plan (GSAMP). This plan supports CVSan in its efforts to prioritize the capital improvement projects which help target some of the most defective pipelines in the almost 160 miles of sanitary sewer main that CVSan is responsible for maintaining. With aging infrastructure, it is critical that our pipeline replacement projects are well-planned to effectively use the funding available. CVSan's Collection System Maintenance Department is constantly collecting new inspection data on our system, which is a critical component of the GSAMP.

VSan's Recycles Day and Compost Give-Away event will be held on Saturday, July 27th, at Canyon Middle School – 19600 Cull Canyon Road. Alameda County residents are invited to drop off household hazardous waste (HHW), such as e-waste, paint, chemicals, pharmaceuticals, and sharps. CVSan residents may also drop off textiles. CVSan residents and businesses can also receive three 1-cubic foot bags of compost! An appointment is required. Registration opens in June. Textile Collection Week



o you have clothes, linens, or towels at home that you no longer use? Between June 3rd - 7th, place bagged textiles on the curb. Please ensure bags are set out by 6:00 a.m. and visible to the Alameda County Industries (ACI) driver. Do not place bags behind or on top of carts.

S anitary sewer easements give CVSan the universal right to use a portion of private property to maintain the wastewater collection system. This provides CVSan with access and rights to repair, replace, inspect, enlarge, change, maintain, test, and/or remove the public sewer main inside of the easement. This means that CVSan workers may go into the easement at any time and may have a contractor present to perform maintenance activities.

CVSan makes every effort to try to minimize impacts on the property owner and does its best to notify property owners before entry; however, CVSan may need to enter without prior notification during a sewer emergency.
