Private Sewer Lateral Program

re you planning to sell your home in spring or summer? Have you checked the condition of your private sewer lateral? When a property is sold, the private sewer lateral is required to meet compliance with CVSan's standards. A closed-circuit television (CCTV) permit must be obtained from CVSan, and the private sewer lateral inspection that a sewer contractor performs must be witnessed by a CVSan inspector. By meeting compliance, CVSan and the new property owner can be assured that the private sewer lateral is free of any cracks, roots, and other defects. June Textile Collection



o you have clothes, linens, or towels at home that you no longer use? Between June 2nd - 6th, place bagged textiles on the curb. Please ensure bags are set out by 6:00 a.m. and visible to the Alameda County Industries (ACI) driver. Do not place bags behind or on top of carts.

• Single-family residents: Set out textiles on your regular collection day.

• Multi-family residents: Check with your property manager for your textile collection day.

Say NO to Wipes



Pictured above is a combination of wipes and dental floss recently removed from one of the pumps at one of CVSan's pump stations. Items other than the 3 P's (Pee, Poop, and Toilet Paper), like dental floss and single-use wipes that are flushed down the toilet, weave together and block pumps and pipes, increasing the chances of a sanitary sewer overflow. Wipes of any kind should never be flushed down the toilet. They belong in the garbage. Please say NO to wipes and YES to the 3 P's! Do You Have an Easement?

f there is a maintenance hole on your property, it likely means you have a sanitary sewer easement. This easement grants CVSan the right to use a portion of your private property to maintain the wastewater collection system. It allows CVSan to access the area to repair, replace, inspect, expand, modify, maintain, test, or remove the sewer main within the easement.

To help maintain access, ensure the area around maintenance holes are free from obstacles and debris. While CVSan strives to notify property owners before accessing their property, it may be necessary to enter without prior notice in the event of a sewer emergency. July Recycles Day!

VSan's Recycles Day will be held on July 26th, at Canyon Middle School – 19600 Cull Canyon Road. Alameda County residents are invited to drop off household hazardous waste such as e-waste, paint, chemicals, pharmaceuticals, and sharps. In addition, this year CVSan residents can exchange one single-use one lb. propane cylinders for a refillable one. Switching to refillable propane is a great way to save money and reduce your waste on your next outdoor adventure!

CVSan residents may also recycle textiles, unwanted poly-woven bags, and film plastic bags, such as chip bags and candy wrappers. Pre-registration is required. For more information visit **CVSan.org/RecyclesDay**.
